

NRE LABS AGREEMENT

Juniper Networks, Inc. (“Juniper”, “we”, or “us”) provides the NRE Labs Portal (the “Site”) for the purpose of fostering the development of learning technologies and services for use with network automation platforms and solutions. By clicking on “I Agree” or “Submit” (if completing a form that includes the Terms), or obtaining information from, accessing, browsing or otherwise using the Site (“use” or “using”), you (either as an individual person or a legal entity, “you” or “user”) acknowledge that you have read, understood and agreed to be bound by the following terms of use (the “Terms”).

Please review the Terms carefully. If you do not agree to these Terms, you should not click on “I Agree” or otherwise use this Site.

If you are an employee of Juniper, you are bound by Juniper internal policies and agreements, so some of the Terms will not apply to you.

Introduction

These Terms govern the relationship between you and Juniper. There may be additional terms and conditions applicable to certain parts or features of the Site, including but not limited to, accessing and downloading of software or documentation, which additional terms and conditions are incorporated herein by reference. If there is a conflict between these Terms and the terms applicable for a certain part or feature of the Site, the latter terms shall control with respect to your use of that part or feature of the Site. We reserve the right to amend these Terms from time to time without specific notice to you. The latest Terms will be posted on the Site, and you should review the Terms prior to using the Site. Your continued use of the Site shall be deemed to conclusively indicate your acceptance of these Terms.

Intellectual Property Rights

Other than Third Party Materials (as defined under “Third Party Products and Services” below), all information, documents, communications, files, text, graphics, software and products available through or related to the Site, as well as their selection and arrangement (collectively, the “Materials”), are protected by copyright, trademark, patent, and/or other intellectual property laws, and any unauthorized use of the Materials may violate such laws and these Terms. Except as expressly provided herein, Juniper and its suppliers grant you a non-exclusive, non-transferable, non-sublicensable, restricted right to use the Materials. You agree not to rent, lease, loan, sell, assign, license, or sublicense works based on the Site or the Materials, except as expressly authorized herein.

Acceptable Use

Other than Third Party Materials (as defined under “Third Party Products and Services” below), the software and documentation that is made available to download from this Site is the copyrighted and/or patented work of Juniper and/or its suppliers. Use of the software and documentation is governed by the terms of the license agreement that accompany or are included with such software or documentation. In most cases the relevant license agreement is the standard Juniper EULA, which are incorporated by reference and can be found here: <https://support.juniper.net/support/eula/>. Such terms are incorporated by reference herein. Installation or use of any software or documentation that is accompanied by or includes a license agreement shall be prohibited unless and until you agree to the terms of such license agreement. If you do not agree to such terms, you shall not use the applicable software or documentation. Absent a license agreement that accompanies the software or documentation, use of the software and documentation will be governed by these Terms. You agree that you will not use the Site or the Materials for any commercial purpose.

You agree not to use any data mining, robots, or similar data gathering and extraction methods in connection with the Site, take action resulting in unreasonable traffic loads, employ any type of bots for the use of scrolling or

showing multiple screens, or engage in other activities that might disrupt ordinary operation of the Site. You are prohibited from violating or attempting to violate the security of the Site. You are prohibited from creating or uploading any computer programs that contain destructive features such as viruses, worms, Trojan horses, or other forms of harmful computer code.

You acknowledge and agree that we have the right to deny use to the Site to any applicant in our sole discretion.

Confidentiality

You acknowledge that your use of the Site may expose you to certain Confidential Information of Juniper. "Confidential Information" means any and all information and material (whether in writing, or in oral, graphic, electronic or any other form) that is marked or described as, identified in writing as, or provided under circumstances indicating it is, confidential or proprietary. Materials shall be deemed Confidential Information. You shall hold all Confidential Information in strict confidence and shall not disclose any Confidential Information to any third party. You shall disclose the Confidential Information only to your employees and agents who need to know such information and who are bound by restrictions regarding disclosure and use of such information comparable to and no less restrictive than those set forth herein. In addition, you shall not use the Confidential Information for any purpose other than in the performance of these Terms. You shall take the same degree of care that you use to protect your confidential and proprietary information of similar nature and importance (but in no event less than reasonable care) to protect the confidentiality and avoid the unauthorized use, disclosure, publication or dissemination of the Confidential Information. This obligation as to confidentiality shall survive any termination of these Terms for a period of ten (10) years. Further, this obligation as to confidentiality is not intended to (and does not) supersede any obligations assumed by you (whether now or in the future) under a separately signed nondisclosure or confidentiality agreement with Juniper or an affiliate of Juniper. Notwithstanding anything contained herein to the contrary, this Agreement does not prevent You from using ideas, concepts, know-how or techniques related to the disclosing party's technology that are retained in the unaided memories of your employees who have had access to Confidential Information, subject to any valid patents, copyrights and semiconductor mask work rights of the disclosing party. The parties understand that each party may, currently or in the future, be developing or having developed for it products or services that are similar to, or compete with, the products or services now offered or which may be offered by the other party. Nothing in this Agreement will prohibit the receiving party from developing or having developed for it products, concepts, systems or techniques contemplated by or embodied in the Confidential Information provided that the receiving party does not violate any of its obligations under this Agreement in connection with such development. In addition, each party shall not have any obligation to limit or restrict the assignment of its employees or consultants as a result of their having had access to Confidential Information from developing or having developed for such party products, concepts, systems or techniques contemplated by or embodied in the Confidential Information.

Trademark Information

"Juniper Marks" means all names, marks, brands, logos, designs, trade dress and other designations Juniper and its affiliates (collectively, the "Affiliated Parties") use in connection with their products or services. You may not remove or alter any Juniper Marks, nor may you use the Juniper Marks in any manner that is inconsistent with Juniper's ownership of such Marks. You acknowledge Juniper's rights in the Juniper's Marks and agree that any and all use of Juniper Marks by you shall inure to the sole benefit of Juniper. You agree not to incorporate any Juniper Marks into any other trademarks, service marks, company names, Internet addresses, domain names, or any other similar designations without Juniper's permission.

Editing, Deleting and Modification

We reserve the right in our sole discretion to edit, delete or modify any Materials appearing on the Site.

Indemnification

You agree to indemnify, defend and hold the Affiliated Parties harmless from and against any liability, loss, claim or expense, including reasonable attorneys' fees, related to your violation of these Terms or use of the Site or any Materials.

Warranties and Disclaimers

Content

Personal Information and Privacy

Termination

Juniper may change, suspend or discontinue all or any aspect of the Site, including its availability, at any time and may suspend or terminate your use of the Site at any time. Either you or Juniper may terminate these Terms at any time for any reason. Upon any termination of these Terms, all license rights granted herein shall terminate and your right to use the Site shall immediately cease.

Juniper's termination of your access to the Site may be effected without notice and, on such termination, Juniper shall not be liable to you or any third party for termination of your account hereunder.

Export Law

To the extent that any export laws, rules or regulations prohibit Juniper from complying with any of its obligations hereunder, such failure shall be excused and shall not constitute a breach of these Terms. You agree not to export from anywhere any part of the Materials, or any direct product thereof except in compliance with, and with all licenses and approvals required under, applicable export laws, rules and regulations.

Equitable Relief

Nothing in these Terms shall prevent either party from seeking appropriate equitable relief, in addition to whatever remedies it may have at law, for any and all of other party's breaches of its obligations under these Terms.

Miscellaneous

These Terms shall be treated as though executed and performed in the State of California, and shall be governed by and construed in accordance with the laws of the State of California (without regard to conflict of law principles). Any cause of action by you with respect to the Site (and/or information, documents and other materials contained therein) must be instituted within one (1) year after the cause of action arose or be forever waived and barred. You expressly submit to the exclusive jurisdiction and venue of the courts of the State of California with respect to all matters relating to these Terms or your use of the Site, and consent to extra-territorial service of process in connection therewith. You are solely responsible for your interactions with other users. Juniper reserves the right, but has no obligation, to monitor disputes between you and other users. Access to the Site are provided at no charge to you. You shall be solely responsible for any costs and expenses you incur because of the Site. Should any part of these Terms be held invalid or unenforceable, that portion shall be construed consistent with applicable law and the remaining portions shall remain in full force and effect. Our failure to enforce any provision of these Terms shall not be deemed a waiver of such provision nor of the right to enforce

such provision. This Agreement constitutes the entire agreement between you and Juniper regarding the use of the Site.
